RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

In consideration of the services of MOUNTAIN ADVENTURE GAMES, and COVENANT COLLEGE, their officers, agents, employees and all other persons or entities associated with those businesses, hereafter collectively referred to as "MAG", I agree as follows:

MAG does not want to frighten me or reduce my enthusiasm for participating, but believes it is important for me to know in advance what to expect and to be informed of the inherent risks associated with participating in adventure activities which may include, but are not limited to, group games, initiative problems, nature hikes, low ropes course elements, and paintball. I acknowledge that MAG operates under reasonable and necessary safety precautions, has taken reasonable steps to provide me with appropriate equipment and skilled facilitators so I can enjoy activities for which I may not be skilled, and has been and will be available to more fully explain to me the nature and physical demands of each activity and the inherent risks.

I am aware that participation in such activities entails risk of loss or damage to property, accidental injury, or in extreme cases, trauma, permanent disability or death, and that there may be other risks either not known to me or not readily foreseeable at this time. I elect to participate in these activities and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation. I certify that I am fully capable of participating in these activities and that if I believe event conditions are unsafe, I will immediately discontinue participating.

I hereby release, discharge, and covenant not to sue MOUNTAIN ADVENTURE GAMES, or COVENANT COLLEGE, its Respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the activity takes place, (each considered one of the "RELEASES" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releases, I will indemnify, save, and hold harmless each of the releases from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement and assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
